**Audience:** Early childhood educators, general and special education teachers, school psychologists,

speech therapists, behavior specialists, para professionals and parents of young students with

**Content:** This half-day training on Peer Mediated Instruction and Intervention (PMII) will focus on

how to involve typically developing peers in promoting appropriate behavior, social and communication outcomes for young students on the Autism Spectrum Disorder (ASD). PMII is an evidence-based practice that can be used to: 1) increase the likelihood of learners with ASD to generalize and use new social skills in different activities and with different peers and; 2) increase the likelihood that social interactions will be naturally reinforced by enjoyable exchanges between peers without disabilities and learners with ASD, while also reducing adult interference. Using lecture, case studies and video clips, the presenter will introduce the participants to a variety of strategies to support students in the preschool

setting.

**Outcomes:** Participants will:

1. Learn about the five types of PMII

- 2. Learn how to select and train peers
- 3. Learn how to provide support and effective feedback to peers
- 4. Learn how to monitor PMII effectiveness and adjust the plan based on data
