Developing a comprehensive and defensible assessment requires accurate data collection, interviews, assessment measures and methodical recommendations. Whether your district utilizes a multidisciplinary approach or a stand-alone/single disciplinary report, this training will equip participants to take into consideration the student's social/emotional/behavioral needs, the review and importance of incorporating existing reports to synthesize the information and generate recommended relevant accommodations, ERMH services and school placement options.
