Play is more than interacting with classmates and manipulating materials. It is a Purposeful Learning Activity for Young children. Young children use play as a medium to communicate their feelings, convey their thoughts, and connect with their world. Typically play develops naturally; however, this is not the case for some children and they require facilitation. Through this training, participants will gain understanding of the stages of object and social play and recognizing the impact of play deficits. Participants will be exposed to evidence- based practices which highlight play as the key context to enrich the early childhood learning environment and support the developmental progress of students.

## **Outcomes:**

Participants will:

- 1. Become familiar with key milestones in the development of object and social play.
- 2. Recognize delayed and disordered play and the associated implications.
- 3. Learn techniques to facilitate the development of play skills.
